Re: NVSS Alert No. 2 – Questionable Reporting of Covid-19

The National Vital Statistics System is the reporting arm of the Center for Disease Control. It is our understanding that on or about March 24 of this year, the accompanying form was transmitted to hospital administrators.

We find this document riveting for its content and phrasing. The following statements in the NVSS Alert cast doubt on the accuracy of corona virus death figures released by CDC/NVSS being broadcast, and in some cases embellished, by corporate media:

1. *‘Because laboratory test results are not typically reported on death certificates in the U.S., NCHS [National Center for Health Statistics] is not planning to implement U07.2 for mortality statistics.’*

This sentence refers to excluding a normally-used designation that would otherwise identify the cause of death as unknown or undocumented. It allows deaths to be ascribed to Covid-19 without supporting evidence.

2. *‘... the underlying cause of death are expected to result in COVID-19 being the underlying cause more often than not.’*

A clear contradiction of scientific and logical principles of data collection. ‘Expecting’ and ‘recording’ are two very different things. The writers of this order aim to assign as many deaths as possible to the corona virus, whether or not it actually causes some of them.

3. *‘If the death certificate reports terms such as “probably COVID-19” or “likely COVID-19,” these terms would be assigned the new ICD code.’ [requiring identification as unsubstantiated] ‘It is not likely that NCHS will follow up on these cases.’*

In other words, if doctors feel the need to use inderminate language (Maybe for reasons of conscience?) NCHS will not be checking to see if such-described deaths did or did not result from the virus. Again, accuracy takes a backseat to the goal of saying deaths are from Covid-19.

4. *‘COVID-19 should be reported on the death certificate for all decedents where the disease caused or is assumed to have caused or contributed to death.’*

If any intended readers did not get the point from the earlier pargraphs, say the cause of death is from COVID, dammit!

Reading this document carefully indicates that the number of actual deaths known to occur from corona virus infections are considered too few to justify the extraordinary measures ordered by state and county health officials.

Why these numbers are being artificially inflated may seem open to speculation. Numerous other indicators point to an over-arching agenda to distract, divide, and dis-empower Americans, while America's and other Nations' societies become less free, less democratic, less transparent; more accommodating to being steered from above; with little or no official oversight or accountability.
